**Sub: FIR in Rajasthan**

**Ref: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we inform you that the Director of Horticulture, Rajasthan has lodged FIR on April 04, 2018 (received by us on April 06, 2018) against Atul Ltd and Mr B N Mohanan, Whole-time Director of the Company with respect to alleged inferior quality of 4,559 date palm plants (being a part of the 1,54,206 plants sold to the Rajasthan Government) supplied to 16 farmers. The Company strongly denies and disputes the claims made against it and is taking the necessary legal steps in the matter. Adverse agro-climatic conditions affected the said plants; while the Company is not liable for any claim, in the interest of the farming community it had offered 1:1 replacement for defective plants as per the directions of the Committees set up by the Rajasthan Government, in 2016/2017. The Company also offered all technical assistance and guidance for farming. Some of the farmers had earlier accepted free replacement, while some others preferred to rather escalate the matter giving rise to the inappropriate and indecorous FIR against the Company.
