3. The company shall discharge the treated effluent meeting the norms prescribed by G.P.C.B. The company shall keep records of the quality of effluents being discharged during the tides as per the recommendations of N.I.O.
4. The company shall submit the quarterly progress report of compliance of conditions.
5. The company shall bear all the costs of the agency to be appointed by the Government for overseeing/monitoring the project activities during construction/operational phases.
6. The company shall comply with all the recommendations, additional conditions and Environmental safeguards prescribed in the report of NIO dated March, 1997.
7. The company shall submit an Environmental Audit Report every year.
8. The company shall obtain the necessary permissions from different government departments/agencies under different laws/Acts.
