Description

Lapox ARF-15 is an unmodified, very low viscosity and high purity, distilled version of diglycidyl ether of bisphenol-F (DGEBF). The specific advantages of it over diglycidyl ether of bisphenol-A (DGEBA) resins are relatively low viscosity at lower temperatures and better chemical resistance. It can be blended with Lapox B-11 (DGEBA type) to prevent crystallisation at low temperature.
