Sub: Disruption in operation at Tarapur plant of the Company due to closure notice from the CPCB

Ref: Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we inform you that the Company has received a notice from the Central Pollution Control Board (CPCB) directing the Company to close the operation of Tarapur Plant of the Company. The Company is taking necessary steps to restore the operation.
