Description

Lapox ARF-14 is an unmodified, medium viscosity diglycidyl ether of bisphenol-F (DGEBF). The specific advantages of it over diglycidyl ether of bisphenol-A (DGEBA) resins are relatively low viscosity at lower temperatures and better chemical resistance. Lapox ARF-14 can be blended with Lapox B-11 (DGEBA type) to prevent crystallisation at low temperature.

Storage and handling
