ECHOES CONCERNS OF TELCOS & TECH FIRMS

Direct-to-mobile tech: DoT arm flags adoption hurdles

JATIN GROVER New Delhi, January 2

THE TELECOMMUNICATION **ENGINEERING** Centre (TEC) has flagged challenges that could crop up in the implementation of direct-to-mobile (D2M) technology, which would pave the way for streaming television content directly to mobile phones without an internet connection.

This comes amid strong opposition to the government's proposal for D2M by technology companies like Qualcomm, Samsung, Ericsson, Nokia as well as telecom operators. TEC has said the integration of smartphones that support D2M and digital terrestrial TV to mobile devices technologies (DTT2M)

remains a big challenge. In its second version of the technical report on the subject "direct broadcasting to mobile handheld devices", TEC has pointed out that the implementation of D2M technology such as Advanced Television Systems Committee (ATSC) 3.0, also known as NextGen TV, might require a new nationwide network for indoor coverage for quality services, which would be complex.

Besides, its implementation would involve higher costs for smartphone makers and will increase the pricing of phones, some stakeholders said in their responses to con**CAUSE FOR CONCERN**

The DoT body also flagged challenges with regard to the availability of a handset ecosystem, scalability of D2M technology, business viability and opportunities and spectrum requirements. "There is consensus now that the success of these approaches relies on the ability to enable this service in mobile devices, more specifically, a smartphone or a tablet. The success of this adoption will further be constrained on how the ecosystem of devices will be created in open-market, lowcost smartphones," TEC said in a report after consultations.

The DoT body, however, said a standard compatible with existing mobile handsets would be required for D2M technology, as it would offer cost-effectiveness and also leverage existing ecosystem support.

By an appropriate and compatible standard, TEC means a framework and protocol that will help in offloading broadcasting traffic over phones, and on the basis of which smartphones can be designed and manufactured to directly receive broadcast signals.

The government's intention behind D2M technology is to explore convergence of broadcasting and broadband services. Through the technology, users can receive terrestrial digital TV content directly on their handsets. The concept is similar to FM radio on phones, wherein phones can tap into radio frequencies.

The technology can possibly be used to directly broadcast citizen-centric information such as issue of emergency alerts, public safety messages, social services, among other things. Using D2M, telcos can also offload traffic, especially video content, to broadcasting network, thereby reducing congestion,

As of today, no mobile devices are available for any of these broadcasting technologies or standards anywhere.

experts said.

In fact, countries like the USA, Brazil, Mexico and Canada among others are running trials for D2M technology.

During consultation over the subject, both telcos and technology companies flagged concerns on government's approach to implement D2M in a hasty manner. The argument of the stakeholders was that since the technology is in early stages, it should not be mandated for devices to comply with that. Telcos also flagged concern over potential loss of revenues from the data business, in case the mobile picks up signals from the D2M technologyin use."The ability by which the D2M/DTT2M operator, based on the technology adopted develops the devices ecosystem and then broadcasts to the tens of millions of open market mobile devices will eventually define the success of D2M in India,"TEC said.

FMCG firms get a flurry of GST demand notices Mumbai, January 2

NESTLE INDIA AND Asian Paints joined an increasing list of fast-moving consumer goods (FMCG) companies to receive tax notices for discrepancies in payment of Goods & Services Tax (GST) for FY17-18.

On Tuesday, Nestle said in an exchange filing that it had received a tax demand notice for ₹15.01lakh from the Commissioner of State Tax, Patliputra, central Bihar, for FY17-18.

The tax authority had also levied a penalty of ₹1.5 lakh on the company, in addition to applicable interest for the period, Nestle India said.

Asian Paints, meanwhile, said on Tuesday it has received three orders for GST demand, totalling ₹2.07 crore from the Andhra Pradesh tax authority. The total amount includes interest and penalties. This follows a notice on Monday

from Chennai authorities. Monday also saw Hindustan Unilever (HUL), the country's largest FMCG company, disclose that it had received five notices amounting to ₹447 crore from five different states.

All the companies said there was no material impact on financial, operations or other activities due to the notices. Nestle and HUL also said they would challenge the orders before the appellate authority.

Indirect tax experts say



that there could be a flurry of tax notices in the months ahead, as the deadline for filing orders for mismatch in tax payment, wrongful availment of tax credits and discrepancies in tax returns filed for FY19 and FY20 lapses on April 30 and August 31 respectively.

"GST is a new tax regime and there will be different positions that companies and tax authorities will take with respect to transactions in the initial years of its implemen-

tation. The tax notices that have been issued of late are for the 2017-18 financial year, whose deadline for filing orders, which are basically show-cause-cum-tax-

demand notices, lapsed on December 31, 2023," said Sohrab Bararia, partner, tax at Grant Thornton Bharat, said.

"There will be more tax notices as tax authorities scrutinise transactions and returns for the next two years," he says.

Last week, Dabur India received a tax demand notice of ₹61.89 lakh by the senior joint commissioner, state tax, LTU, West Bengal, which was the second notice for the company in three months.

In October, the company had received a ₹320.6 crore tax demand notice from the Directorate General of Goods & Services Tax Intelligence, Gurugram unit.

Govt hikes windfall tax on crude oil

THE GOVERNMENT HAS hiked the windfall tax on crude oil produced in the country and cut the levy to nil on exports of diesel and aviation turbine fuel (ATF).

The tax, levied in the form of Special Additional Excise Duty (SAED), on domestically produced crude oil has been raised to ₹2,300 from ₹1,300 pertonne, according to an official notification.

The SAED on the export of diesel has been reduced to nil from ₹0.50 a litre.

The levy on export of jet fuel or ATF has been cut to nil from ₹1 per litre.

SAED on petrol will continue to be zero. The new rates are effective from Tuesday.

India first imposed windfall profit taxes on July 12022, joining a growing number of nations that tax supernormal profits of energy companies.

Kerala signs pact with **IBM** for Kochi hub

THE KERALA GOVERNMENT on Tuesday signed an in-principle agreement with IBM India to start the IT giant's hub in Kochi to make the city a centre for AI-assisted technology.

The state government will host a Global Artificial Intelligence Summit in Kochi in the middle of this year as part of the initiative, industry minister P Rajeeve said.

"By becoming the AI hub of IBM, Kochi will see an influx of top technology professionals from across the globe," the minister said, noting that the trend will also imply a reverse migration.

"This will particularly benefit the new generation in IT. Also, it can double the number of IBM staff vis-à-vis the prevailing total," Rajeeve said. —FE BUREAU

1.2. The Buy-back commenced on Tuesday, November 21, 2023, and closed on Monday, January 01, 2024 (both days inclusive). Intimation informing the closure of the Buy-back was sent to the Stock Exchanges on Saturday, December 30, 2023.

 Till the date of closure of the Buy-back, the Company has bought back 72,000 Equity Shares at an average price of ₹ 6,934.70/- per Equity Share for an aggregate consideration of ₹ 49,92,98,270/- (Rupees forty nine crores ninety two lakhs ninety eight thousand two hundred and seventy only) excluding Transaction Costs which represents 99.86% of the Maximum Buy-back Size.

Details of Buy-back

2.1. 72,000 Equity Shares (representing 0.24% of pre-Buy-back outstanding equity shares of the Company) were bought back under the Buy-back at an average price of ₹ 6,934.70/- per Equity Share. The price at which the Equity Shares were bought back was dependent on the price quoted on the Stock Exchanges. The highest price at which the Equity Shares were bought back was ₹ 7,130/- per Equity Share while the lowest price was ₹ 6,570/- per Equity Share. These prices are based on contract notes issued by Nuvama Wealth and Investment Limited ("Company's Broker") and exclude Transaction Costs.

The total amount utilised in the Buy-back is ₹ 49,92,98,270/- (Rupees forty nine crores ninety two lakhs ninety eight thousand two hundred and seventy only) excluding the Transaction Costs which represent 99.86% of the Maximum Buy-back Size.

2.3. The pay-out formalities shall be completed as per settlement mechanism with the Stock Exchanges. The Company has extinguished 8,265 Equity Shares bought back on December 12, 2023 and is in the process of extinguishing remaining 63,735 Equity Shares bought back in the Buy-back Offer.

2.4. All Equity Shares bought back were in the demat segment from the Stock Exchanges. No physical shares were accepted or bought back in the Buy-back. जनसत्ता ब्यूरो नई दिल्ली, 2 जनवरी।

मनरेगा के लिए आधार-आधारित भूगतान तंत्र (एबीपीएस) शुरू किए जाने पर कांग्रेस पार्टी की ओर से केंद्र सरकार की आलोचना पर केंद्रीय ग्रामीण विकास मंत्री गिरिराज सिंह ने शनिवार को पलटवार किया। मंत्री ने कहा कि वर्तमान समय में मनरेगा के मजदरों को 100 में से 100 पैसा मिल रहा है। उन्होंने कहा कि कांग्रेस और पूर्व प्रधानमंत्री राजीव गांधी के समय एक रुपए में से 15 पंद्रह पैसे ही लोगों तक पहुंच पाता था।

गिरिराज सिंह ने कहा कि कांग्रेस और उसके नेताओं की अच्छे कामों के खिलाफ बोलने की आदत रही है। कांग्रेस के नेताओं ने जनधन खाते खोलने की शुरुआत हो या प्रत्यक्ष लाभ हस्तांतरण (डीबीटी) योजना की शुरुआत, इनकी भी आलोचना की थी। उन्होंने कहा कि कांग्रेस के राज में महात्मा गांधी राष्ट्रीय ग्रामीण रोजगार गारंटी योजना (मनरेगा) कुकर्मों का जाल और लूट की दुकान थी लेकिन प्रधानमंत्री नरेंद्र मोदी की सरकार में मनरेगा में पुरी पारदर्शिता के साथ काम हो रहा है।



मनरेगा के मामले पर केंद्रीय मंत्री गिरिराज सिंह ने कांग्रेस पर किया पलटवार, कहा, उनके समय में लूट की दुकान था मनरेगा।

उन्होंने कहा कि आधार-आधारित भुगतान तंत्र (एबीपीएस) के लागू होने से मजदूरों को लाभ होगा। अगर कोई मजदर अपना मोबाइल नंबर बदलता है तो भी उसको भूगतान प्राप्त करने में समस्या नहीं होगी। इसके अलावा ऐसे लोग जो गलत तरीके से भगतान ले रहे हैं, वे व्यवस्था से बाहर होंगे।

मंत्री ने कहा कि वर्तमान में 99 फीसद मजदुरों के आधार नंबर को तंत्र में स्थापित किया जा चुका है, जिनका नहीं हुआ है, उसके लिए हम राज्य सरकारों से बात कर रहे हैं।
